ARBITER INFORMATION

- OFFICIALS RESPONSIBILITIES/INPUT:
- Contact partner's
- Arriving at game site's.
- Reporting (cards) comments and incidences & Ratings (www.nysoccerbureau.com)
- Picture in Arbiter, video reviews (website suggestions)

OFF SEASON PREPARATION

- Knowledge of the game (video, watching)
- Clinics
- Fitness
- Integrity



RECEIVING SCHEDULE

- Review Schedule
- Don't let ego override common sense. If you cannot handle the match either physically or mentally turn it back.



PRE MATCH CHECKLIST

- Call your Crew, Set up travel arrangements
- Discuss Colors you will be wearing.
- Leave an e-mail with school letting them know what time you will be arriving and if there are any changes.
- Study the teams
 - Best players
 - Team records
 - Names of Coaches and Trainers
 - Athletic, direct players



ARRIVAL

- Dress appropriately
 - You never know who will be meeting you at the site of competition.
- Walk the field prior to changing
 - This is the time to point out discrepancies.
- Be professional
 - You never know who is listening



PRE-GAME

- Ask your crew if they studied the teams. If match is competitive you may want to reach out to prior crew for feedback. (Previous Box Score)
- Go over the rule book, especially substitutions, injuries, blood on uniform , concussions. It is critical to know this as we don't need any games Protested!
- Constant eye contact.
- Make sure A.R.'s have writing material
 - A.R. 1 & 2 (whistle/cards/coin)



PRE-GAME

- When and how cautions are issued.
 - Who writes, Who watches the field
 - Compare at half time.
 - Who is watching the clock for stopping/starting?
 - What happens during issuing of Red Card (Fighting).



PRE-GAME

- DOGSO/Denying obvious goal scoring opportunity.
- 4 D's/Direction, Distance, Defender,
- Did player have ability to control ball?
- Take the time to get together to get it right!

PRE-GAME

- Let the A.R.'s know the following:
 - P.K. standards and positioning
- What is A.R. signal if they call the P.K.?
 - Offside (Late and correct is better)
 - Far, middle, near
 - End line and Touch line in their quadrants.
 - Ball in and out of net. What is the proper mechanic?



NEW OFFSIDE RULE

- Referee and AR
 - This has to be addressed pre-game. (Tony)

NEW OFFSIDE RULE

- Not Deliberate
 - Reaction: is not a deliberate play
 - Unexpected: no clear line of sight
 - Factors: Time, Distance and Speed of ball
 - A reflex movement
- Deliberate
 - Clear line of site to ball
 - Factors: Time, Distance and Speed of Ball

2016-2017 RULES

- NCAA/ARBITER SPORTS

REFEREE/AR 1 PRE-GAME BENCH SIDE BEHAVIOR

- Know the coach's that you are dealing with that day!
- Let AR know what you will and will not tolerate from the benches that day.
- Let the AR know that if he is having difficulty concentrating then you need to know immediately!
- Don't engage in unprofessional dialogue with the Coach/Assistant Coach or Players. Remember, they are all witnesses to the incident.
- Be professional at all times, remember there is video!

ARE YOU APPROACHABLE?

- We will be dealing with many player and coaching personalities during matches (Male/Female).
- You will need to adapt to 22 player personalities during each match.
- You need to know when to listen and when to speak.
- Remember, communication can be non-verbal as well.

DOES THE MAGNITUDE OF THE GAME ALTER COACHES AND REFEREE'S BEHAVIOR

- It most certainly does!

WHAT TYPE OF COACH ARE WE DEALING WITH AND WHEN DO WE ADDRESS THEM?

- Professional Coach
 - Sits on bench during match.
 - Concentrates on team and not referee's.
 - When they have a concern they address you as sir or referee and not by name!
 - When they do address and answer is given, they may agree or agree to disagree and then they return to their bench.

PROFESSIONAL COACH

- How do we deal with this type of coach during incidents in question?
 - Be respectful. We don't want to alienate a coach that gets it!
 - Be a better listener with this type coach.

WHAT TYPE OF COACH ARE WE DEALING WITH?

- Constant Complainer
 - Questions most decision to include touch line balls.
 - Continually asks questions even though they know the answer.
 - Shadows the bench side AR.
 - Doesn't allow the AR to concentrate.
 - Constantly complaining to his bench players about referee decision but when addressed by referee gives the answer "I was talking to my players".

CONSTANT COMPLAINER

- How do we deal with this type of coach during incidents in question?
 - Don't rush to the touch line to address.
 - Give them minimal time for discussion as they have been discussing the match since the whistle was blown!
 - Pull them away from their bench and up to the touch line. No one needs a witness!
 - Be calm, don't let them know that they may have broken your concentration level.

WHAT TYPE OF COACHES ARE WE DEALING WITH?

- The Screamer!
 - Constantly yelling!
 - Will not listen!
 - When we respond they respond with a sarcastic answer!
 - **DOES NOT ALLOW THE AR TO CONCENTRATE!**

THE SCREAMER!

- How do we deal with this type of coaching behavior?
 - When they are breaking the concentration of the Bench Side AR, they need to be dealt with immediately!
 - Focus on the match and don't let them break your concentration.
 - When the screaming crosses the line of being personal, no need to have conversation, deal with them in terms of Yellow or Red!
 - Bring them to touchline. Again no need for witnesses.

- How do we handle them?
-**WE DON'T!**

- No foul is considered what?
 - A FAIR CHALLENGE



REFEREE FOUL RECOGNITION

- CONSIDER THE FOLLOWING:
 - -POINT OF CONTACT
 - -DIRECTION OF CONTACT
 - -TIME OF CONTACT
 - -INTENT OF CONTACT
 - -SEVERITY OF CONTACT
 - -RESULT OF CONTACT
 - -DISTANCE
 - -SPEED

REFEREE FOUL RECOGNITION

- BE MINDFUL OF CONTACT:
 - - BEFORE BALL ARRIVES
 - - AS BALL ARRIVES
 - - AFTER BALL IS GONE
 - - DURING A “BREAK AWAY”
 - - IS THIS NORMAL CONTACT FOR THIS LEVEL OF GAME.

REFEREE FOUL RECOGNITION

- - AMOUNT OF FORCE
- -VERTICAL OR HORIZONTAL
- -LEG (s) POSITION (straight or 2 leg)
- -LAUNCHED
- -ELBOW
- -HEAD
- -ANKLE
- -KNEE
- -THIGH

REFEREE FOUL RECOGNITION

DIRECTION OF CONTACT ON BODY:

- - FRONT
- - SIDE
- - BEHIND

POST SEASON 4TH REFEREE

- Don't live in a coach's/teams area!
- Be an excellent listener!
- Don't throw crew under the BUS!
- In case of major incident get on the field and face the team areas. Take numbers if necessary.
